# AYSO Region 13 Board of Directors' Minutes November 13, 2014

- Call to Order Al

- October Minutes The minutes were approved via email. Al announced that he is now going to have the Agenda and Minutes posted on our website as one document as opposed to two separate ones.
- Coach's Report Heidi
  - The web page has been updated regarding the Graduation Series.
  - o The last games for U6-8 are this weekend.
  - o There were some issues in U10 this last weekend.
  - There have been two tryouts for MST and All-Stars to date with approximately 25 per cent attendance.
  - o The MST teams have been picked however, there are referees needed for GU10 teams.
  - She is meeting with Launch on Tuesday re training.
- U5 Division Coach's Report Frank
  - o Frank reported that the U5 is has completed play and he distributed trophies and a Halloween goodie bag.
  - O Approximately, 2/3 of the registered players were in attendance on each play date.
  - He received a few complaints this season from parents that the sessions interfered with nap time.
  - Frank suggested that the biggest improvement to the program would be to LOCK the North gate for Muir Central to allow for more available parking on Montana for U5.

- Playoffs Bill
  - Our last regular game is this weekend. The first playoff game is next Saturday. Assuming that he receives all of the game cards from this weekend, he hopes to have the schedule completed very soon.
  - After discussion, he will prepare a schedule with no playoff consolation games and avoid scheduling conflicts with tryouts.
- Fields Marco
  - o Marco advised that with Mr. Tom Sobota's help, the Region's portable lights have all been repaired.
- CVPA Pamela Morgan unavailable
  - Al indicated that there were relatively few problems this season.

  - o It was proposed that he include additional levels of AYSO administration in his email process in the future.
  - Chris suggested the possibility of using an online merchant account to make collecting sponsorships easier.

  - The MST uniforms have been ordered. The will be kept and reused for two years. She ordered jerseys and socks only (though only the jerseys will be reused).
  - O We will not ask for security deposits from players this season.
